# FROM THE PRESIDENT

It is extraordinary to see such a grand vision come to fruition. The partnership that the Community Foundation created between our three counties has done countless remarkable things for our communities in terms of assisting those in their times of need. Our organization faced many new challenges this year as technology evolves and advances. We've done a lot of problem solving and created new processes that make us even stronger as an organization. In the past few years, we've had the opportunity to celebrate some big milestones such as Howard County's 30th anniversary and Clinton County's 25th anniversary. This year was no exception as we celebrated the Carroll County Community Foundation's 25th anniversary.

The Carroll County Community Foundation started as a fund of the Community Foundation of Howard County, Inc. on August 29, 1997, by action of the Foundation's Board of Directors. That action meant that the Foundation now served donors in Howard, Clinton and Carroll Counties. The Carroll County Community Foundation operates through a "County Services Committee" comprised of Carroll County residents. This committee is responsible for asset development and the review of grants and distributions. The committee receives staff and technical support from the Community Foundation of Howard County, Inc. In addition, representatives from Carroll County serve on the Board of Directors of the Foundation.

The Carroll County Community Foundation began with one fund in 1997 and has now reached assets of \$18,977,540.53. Since 1997, the Carroll County Community Foundation has invested in the community through grants amounting to \$4,023,672.59.

Overall, the Foundation has been extremely busy! In 2022 we've grown to over \$103 million in assets and 578 funds. All of this wouldn't be possible without the belief and investment you make in the Foundation. As the landscape in the nonprofit sector changes, we've grown with it. Looking ahead I see only grand opportunities for the Foundation and exciting new things on the horizon.

It is with a bittersweet sense that I share with you that in 2022 I notified the Foundation Board and staff of my plans to retire mid-2023. It has been one of the greatest pleasures of my career to be a part of all the brilliant things this organization does and is doing. # Healthier and happier pets at the Humane Society



### CULTIVATING COMMUNITY IN HOWARD COUNTY

The <u>Kokomo Humane Society</u> (KHS) is one of those organizations where less is better than more. In other words, fewer animals in their care means less money is needed for housing, food, and medication.

One way that the Community Foundation of Howard County is helping to cultivate the community is by supporting KHS in its efforts to implement a new Community Pet Assistance Program. A \$5,000 grant from the Foundation's Community Endowment Fund is helping the Humane Society implement an initiative to assist the community in the care of its pets and improve the health of the general animal population in the shelter.

Most people think of the Humane Society as a place primarily for pets without a home. This new program would actually focus on an unmet need in the community -- owned animal care.

For example, many families have space in their homes and their hearts for pets, but often have trouble providing the proper care or even food for an animal. The Pet Assistance Program can provide subsidies that help KHS by reducing the cost of resources that currently go to medical care, and housing for lost and surrendered owned pets by providing effective animal identification methods and disease and overpopulation prevention.

KHS will utilize the Community
Foundation grant to help supply owned animals
with microchips, identification tags, vaccines,
flea and heartworm prevention, and spay/neuter
procedures. Providing preventative resources
through the program will result in a healthier and
happier pet population in the community.

The Community Foundation's investment in the Community Pet Assistance Program will also help reduce KHS operational costs, improve services, and enable the organization to redirect resources to expand and improve other programs at the shelter. The need is still timely based on the ongoing pandemic. As people had to prioritize spending, the needs of beloved pets were often at the bottom of the list. The Humane Society has resources available to help, but since 2020 fundraising has not kept pace with operational needs.

The program is crucial and a cost-effective cycle of support. The more services and products that KHS can provide to pet owners in Howard County actually helps the organization manage its costs, because fewer animals – and their owners – will ultimately be turning to the Humane Society for further care and support.

The program has well-defined and measurable goals as part of many ongoing and larger projects. For example, by providing identification to every animal they vaccinate, the Humane Society can decrease the number of stray pets coming into the shelter and reduce the length of stay by two days. They also hope to see fewer animals in the shelter who need to be treated for illness because of the preventative care.

Vaccines, IDs, surgeries and a host of preventative protections can all be used to meet these goals. The funding will be applied carefully and thoughtfully, and through KHS's mindful use of resources, the organization will be able to improve conditions at the shelter while maintaining and growing the Community Pet Assistance program. The Community Foundation funding can help KHS meet those goals.

# A Symphonic Soundtrack for Kokomo

CULTIVATING COMMUNITY IN HOWARD COUNTY

A unique concert event played out Oct. 1, 2022, for a large audience at Havens Auditorium on the campus of Indiana University Kokomo when the <u>Kokomo Symphony</u> presented "Mozart to the Moderns" as part of its 2022-2023 season.

The performance that evening in Kokomo, Indiana, included Mozart selections featured in the Academy-Award Winning 1984 film "Amadeus," as well as 1920s-era compositions "Le Bœuf sur le toit, Op. 58" by Darius Milhaud, written to accompany the silent films of Charlie Chaplin, and "A Jazz Symphony" by George Antheil – a fusion of styles calculated to create thoughtful and interesting listening experiences for Kokomo concertgoers.

Pulling off what proved to be a stunning night of sound required some amount of planning and preparation by the Kokomo Symphonic Society (KSS), Inc., including payment and expenses for 60 musicians to cover three rehearsals and the concert date. Help for these and other related costs included a \$5,000 grant from the Community Foundation of Howard County's Community Endowment Fund.

"Mozart to the Moderns" was the latest in a series of special programs offered by KSS. Its mission is offering an entertaining and educational music experience for the community with a reasonable and affordable admission fee. KSS strives to set ticket prices so many in the community can attend, compared to the costs for similar events in larger cities.

What's more, KSS pricing plans are specifically tailored to build a young audience. Fees for college students are lower and there is no charge for other students and children. The benefits of exposing kids to

culture are well-documented. KSS points to research showing that if a child listens to orchestra music at a young age, they may have better or improved communication, cognitive and motor skills, it can refine spatial-temporal learning, and also strengthen a child's immune system. When children want to attend, they bring their parents along as well. KSS touts the benefits of families sharing music and attending that first concert often leads to repeat performances.

A strong symphony presence strengthens the community in a myriad of ways. Given its size, KSS relies on a complement of largely out-of-town professional musicians (including the conductor). This drives an increase in visitors for Kokomo businesses, restaurants and hotels, as musicians' families and other guests may come for concerts as well. Also, positive cultural events and experiences in the Kokomo community are often important considerations for families making relocation choices.

Classical music has been a part of Kokomo's soundtrack for 49 years thanks to the Symphony and its sponsors. KSS works to fashion unique programs and relies on audience surveys and various marketing tools to guide future planning and performances. In addition, KSS benefits from solid media support across a variety of publicity platforms in the area.

This leads to a strong number of repeat seasonal individual patrons and solid support from area businesses and organizations. Indeed, the Foundation's "Cultivating Communities" effort helps to ensure that Kokomo and Howard County residents will continue to enjoy the sounds of the Kokomo Symphony.

# Project Life Saver Brings People Home

### CULTIVATING COMMUNITY IN CLINTON COUNTY

Since 2019, Project Life Saver (PLS) of Clinton County in Indiana has become a unique and valuable service in the community by providing a timely response that can help save lives and reduce potential injury to adults and children who may either leave their home or leave the presence of a parent or caregiver – known as wandering -- due to a cognitive condition.

As a fully sanctioned Public Safety Program, PLS works with local public service and health care providers to help protect and locate missing persons with Alzheimer's, Autism, Down Syndrome, or other cognitive conditions. The organization follows industry guidelines and stays current with technology tools and techniques. Plus, PLS helps to educate residents about the causes and conditions that can lead to "elopement," the clinical term for wandering.

As the organization has matured, in 2022 PLS leadership identified two ways to continue to grow. The first was for members of the Board of Directors to obtain training important to maintaining national safety program standards. The second was to define and implement an aggressive marketing campaign to add new clients.

Project Life Saver is built around creating a suitable service for an at-risk individual and then providing support for family members or caregivers.

For example, the service that helps family members know if a loved one has left the house includes a device placed in the home that tracks a signal from the client's bracelet. An alarm sounds if the bracelet goes more than 100 feet from the monitoring device. It's a simple system that provides enormous peace-of-mind for a family.

Targeted marketing would help PLS easily show the value of this service as part of a long-term goal to get as many individuals in Clinton County enrolled in the program as possible. To help market the service, a budgeted promotional plan was developed to use social media and share information through press release details to news media and other groups. PLS also utilized local festivals, fairs, and other events to share information with the community.

The plan took an even more targeted approach by providing local doctors with information to better assist patients and their families.

The plan was ambitious but well-defined, and PLS turned to the Clinton County Community Foundation for funding help. Going forward, progress can be tracked by evaluating the roster of currently enrolled clients. PLS locally holds board meetings once a quarter in the calendar year, where active and potential client information is evaluated in line with the marketing and board development plans.

With a \$3,000 grant from the Robert K. & Eleanor Ryan Community Fund, the Community Foundation is helping to "cultivate the community" with support for a Clinton County organization that literally lives up to its motto of "bringing loved ones home."

# More Than Music at the Delphi Opera House

CULTIVATING EDUCATION IN CARROLL COUNTY

Carroll County citizens in north central Indiana commonly create coalitions for community improvement projects, like historic preservation or area beautification, to improve quality of life. Expanding educational programs for county students is always a priority, and typically is aligned with the contemporary emphasis on science and math.

But the humanities are not neglected, and one Delphi, Indiana-based organization recently saw a way to develop and support an arts enrichment program for area students by utilizing its most unique asset – the award-winning 157-year-old Delphi Opera House.

Building on the successful 20-year restoration of the building by the Delphi Preservation Society, which was completed in 2015, the Opera House organization's board of directors and volunteers were now seeking to make the premier facility available by working collaboratively with members of the county's arts community, area schools, homeschool cohorts, libraries, and other youth groups to develop arts programs based on community-defined areas of greatest need.

The scale was ambitious and well-suited to such an impressive space -- to bring together many entities dedicated to the arts and youth to work collaboratively, to create synergies and build community networks. Therefore, the budget would need to cover the cost of program planning and development, provide instructional stipends as needed, address materials, supplies, facility upkeep and cleaning, and allow for various miscellaneous costs.

As a budget proposal began to take shape, the Opera House team also saw a potential grant request as a stepping stone to an even larger grant for arts education from the National Endowment for the Arts. This led them to apply for a grant with the Carroll County Community Foundation. An \$11,000 grant was approved from two sources: the Alan and Katrina Coghill Family Community Fund and the Carroll County Community Endowment Fund. This funding from the Foundation will help the Opera House organization as it works locally to start developing, refining and ultimately implementing a broad needs-based portfolio of arts programming that can produce positive results for youth in the community.

Plus, serving a more diverse and potentially underserved audience is a primary goal of both organizations.

Additionally, as the process moves forward, the entire community will benefit as participating

children and youth showcase their work in productions and shows hosted at the very venue that is providing the programming.

Future success will be measured by the number of children and youth who participate per program, and this baseline will be used to identify gaps and prioritize future program content. Community volunteers, a strength of the organization, will play a big role, with a long history of helping successfully manage and implement similar projects on a smaller scale in the past.

The Foundation's "Cultivating Communities" effort will help bring the arts to more people daily in Carroll County and supports the Delphi Opera House as it embraces the motto of the Indiana Arts Commission: "the arts everywhere, every day, for everyone in Indiana."

# Preserving History at the Flora Depot



#### CULTIVATING EDUCATION IN CARROLL COUNTY

After almost a decade of fundraising, applying for grants, and enlisting a helpful and willing group of volunteers, the Flora, Indiana, community welcomed an important new addition to their town when the historic 1908 Flora Depot was opened in 2022. Members of the Flora Depot project team had spent years acquiring a range of items unique to the area's local history, and their efforts were officially recognized during Flora's Sesquicentennial Celebration on Sept. 24, 2022, with the opening of a railroad and local history museum designed to display the collection.

The goal was to create a vibrant and dynamic space where residents and visitors alike can learn more about the area's rich rural heritage. Artifacts and exhibits will be designed to help increase knowledge and provide better understanding and appreciation for local history.

Carroll County, Indiana, residents have a long history of supporting cultural heritage efforts like the Flora Depot. That support requires a high standard of care and commitment to the preservation, maintenance and safekeeping of artifacts.

To achieve this, a team of volunteers helps to catalog and organize items in the Depot archive. The team also maintains a process-management record of the way items are cataloged and stored, which will be an important resource for future volunteers, curators and archivists who will help manage the collection.

challenging and tedious at times, running a local-history museum is interesting and rewarding work.

The Flora Depot team handles everything from authentic documents to unique period clothing to irreplaceable photographs. Their professional approach to curating and cataloging the items is important for preservation and future access.

To reach this level and to maintain it going forward, the project team identified a range of material needs to support the collection. These included basic but vital archival materials to properly store and preserve photographs, as well as structural supporting items for antique and vintage clothing, and physical storage space for documents and artifacts.

The project team also works collaboratively with other local history organizations, as well as the Flora Public Library, to take advantage of shared resources and expertise. The Depot project was well-positioned from earlier funding and building a strong volunteer base, but a need was seen for a digital camera and portable photography light box to extend the scanning and digital preservation capabilities.

So, the team applied for a grant from the Carroll County Community Foundation for that extra help to purchase the new equipment. With a \$1,250 grant from the Foundation's Richard L. Funkhouser Fund, the Depot team now has the right combination of tools, training and technology to support current and future preservation projects. The Foundation's "Cultivating Communities" effort will help ensure that residents and visitors will be able to explore and learn about Flora, Indiana's interesting history for years to come.



# Sensors for Science in Schools

#### **CULTIVATING EDUCATION IN CLINTON COUNTY**

The report card has a big A+ for the expanded STEM curriculum for young scholars at Clinton Central Elementary in Michigantown, Indiana.

This effort is core to Clinton Central School <u>Corporation</u> providing hands-on learning projects that expose students to innovation and help them learn criticalthinking skills. The goal is to create an environment where the educational experience is rigorous and relevant. Beginning in the 2021/2022 school year, everyone from pre-kindergarten to sixth graders now participates in a weekly STEM (science, technology, engineering and mathematics) class.

At every level the students seem engaged and enthusiastic. Even 5-year-olds know how to use handheld devices and tablets, so students today seem to easily embrace new tools and equipment. What Clinton Central Elementary has discovered is how adaptable and responsive students are when they are building, testing and making adjustments to science and evidence-based projects that they can create and monitor.

For analyzing and monitoring STEM projects, the school saw that adding an extension to the current desktop and tablet tools would help the students take precise measurements and work with dynamic real-time data.

With the help of a \$1,695.65 grant from Clinton County Education Program Fund available from the Clinton County Community Foundation, the school was able to introduce an industry-standard, professional-grade handheld sensor for students to use in their work. Indeed, the Foundation's "Cultivating Communities" effort helps ensure students at Clinton Central Elementary School are being prepared for the science labs in high school and beyond.

Additionally, the sensor app works with an assortment of technology and supplies including robotics kits, electrical components, 3D printers, construction kits, and recycled materials the school maintains for use in the development and implementation of the learning activities. These can all now be measured with the new sensor tools.

And students have learned that collecting and analyzing data can be fun! For example, one of the Indiana science standards for kindergarten requires students to "analyze data to determine if a design solution works as intended to change the speed or direction of an object with a push or a pull."

Students could explore this standard by trying wheels made from different types of materials on a toy car. While they could make visual observations about the speed of the car, the new sensor provides students with concrete proof of the change in speed depending on the wheel

In another example of the sensors' value, a fourthgrade science standard has students "make observations to provide evidence that energy can be transferred from place to place by sound, light, heat, and electric currents." Students could work with a partner to construct examples of series and parallel circuits and then use the handheld sensor to compare the light intensity of the bulbs in each type of circuit.

What's more, the sensors give students real-world experience, just as they would if collecting data with methods similar to scientists in academic or professional settings.
